Double glazed window and door to side, stairs off and central heating radiator.

Double glazed windows and door to rear and central heating radiator.

Kitchen/Diner

20'8" x 8'10" (6.3 x 2.7)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, space and plumbing for washing machine, tiled splash backs and door to side.

Double glazed window to front and side and central heating radiator.

Double glazed window to side and doors off.

Wash hand basin with mixer tap and storage below, WC and extractor fan.

Double glazed window to rear, central heating radiator and fitted wardrobe.

Double glazed window to side.
