Driveway to front with neat and tidy lawn area.

Entrance Hall

Spacious hall with door off to lounge, central heated radiator.

Gas fire with surround, double glazed bay window to front and side window, stairs rising to first floor, two central heated radiator.

Dining Room

Doors open to the rear garden, central heated radiator.

Kitchen

Variety of wall and base units, integrated fridge/freezer, sink and drainer, plumbing for washing machine, double electric oven, four ring gas hob with extractor above, double glazed window to rear.

Wash hand basin, w.c, double glazed window to side.

Doors radiating off, loft access.

Fitted wardrobes, double glazed window to rear with far reaching views, central heated radiator.

Double glazed window to front, central heated radiator.

Double glazed window to front, central heated radiator.

Bath with shower over, wash hand basin, w.c, chrome heated radiator.

The Location

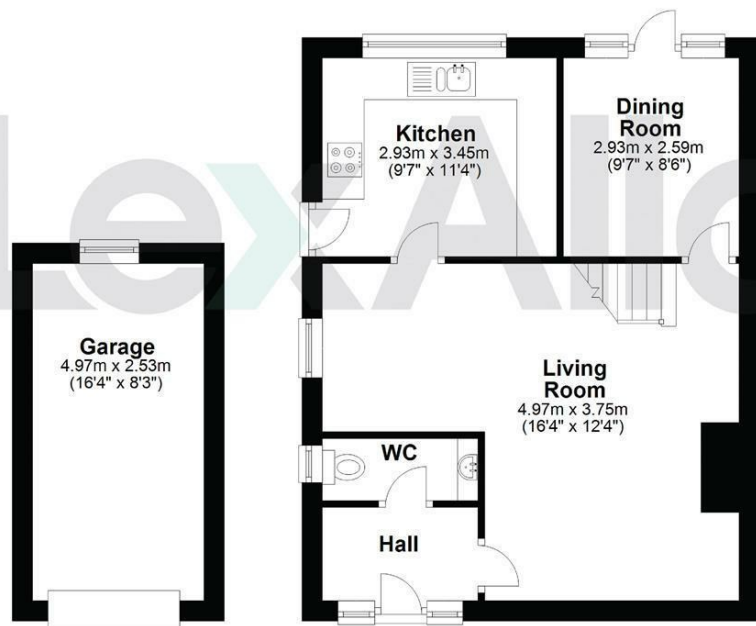

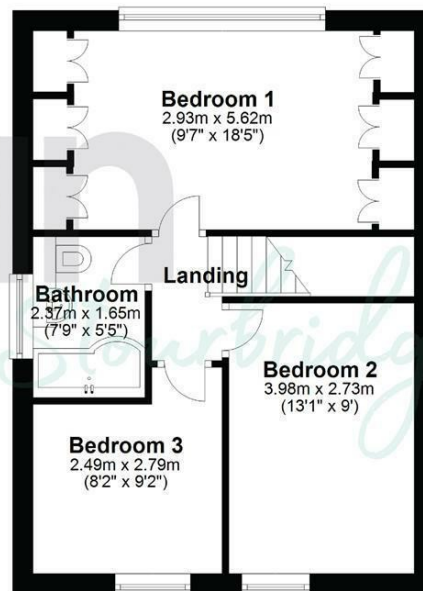
Ground Floor
