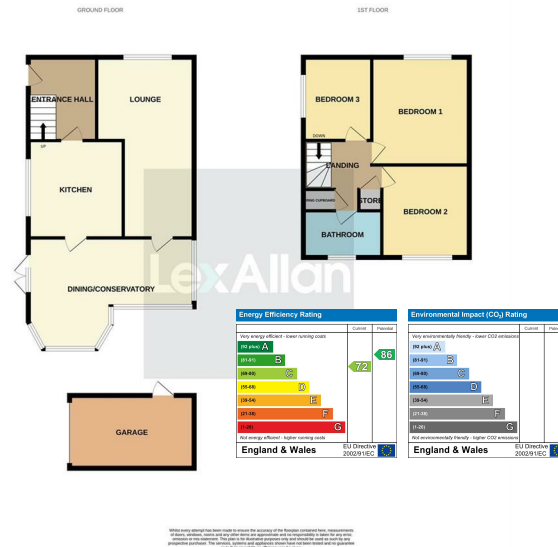
Referral Fees.
