Approach

Driveway offering parking for a number of cars and slate chip bedding.

Porch

Door to front and access into:

Entrance Hall

Stain glass door, central heating radiator, cupboard and stairs off.

Dining Room

Double glazed window to front, central heating radiator and feature fire place.

Lounge

12'5" x 23'3"

Double glazed windows and doors to rear, central heating radiator and feature fire place.

Kitchen

10'2" x 19'8" min 23'7" max

Double glazed window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, oven, tiled splash backs, breakfast bar, log burner and central heating radiator.

Patio areas, lawn, raised flower beds, all with fencing and hedging to enclose.

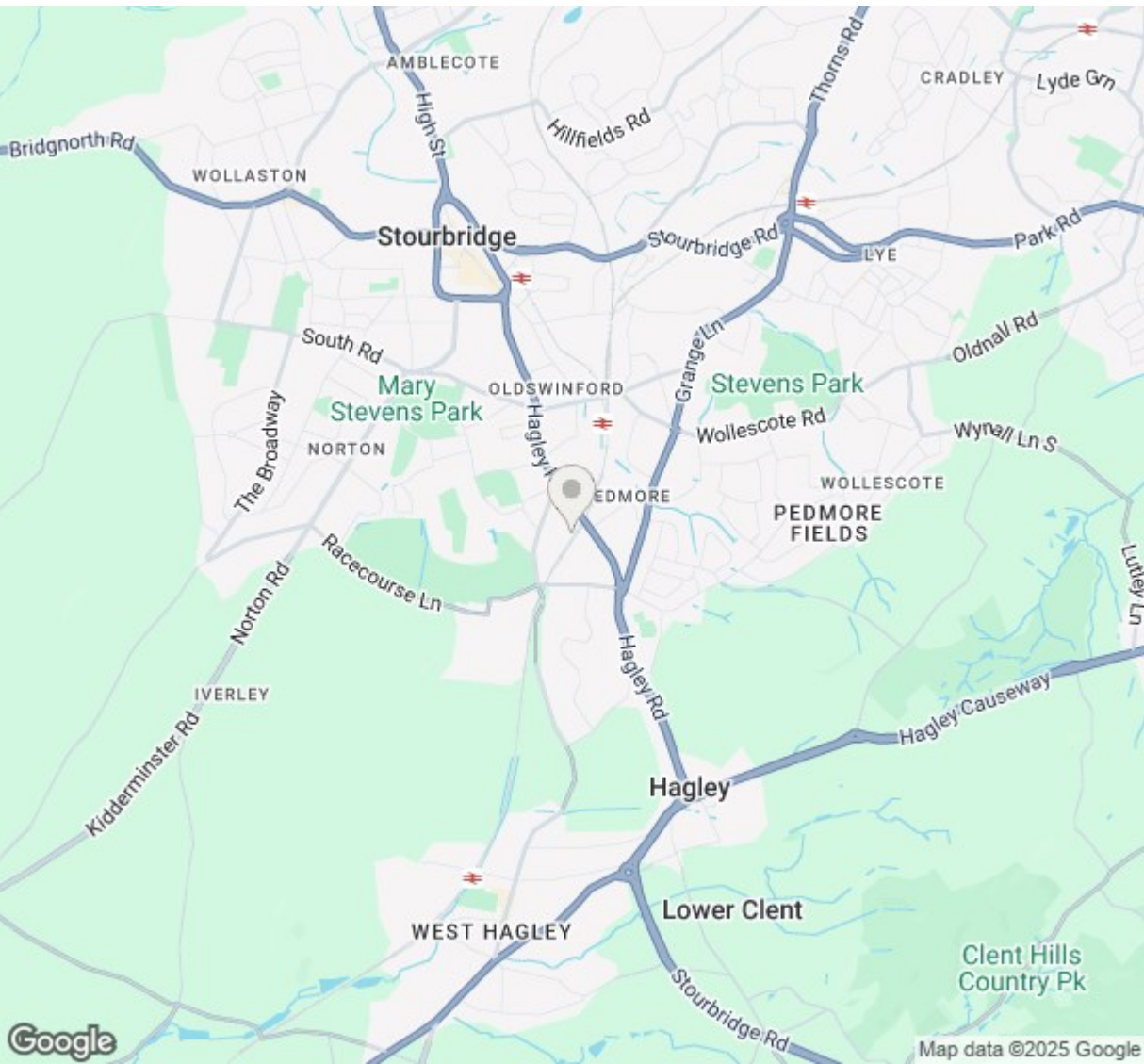

Tenure (Freehold).

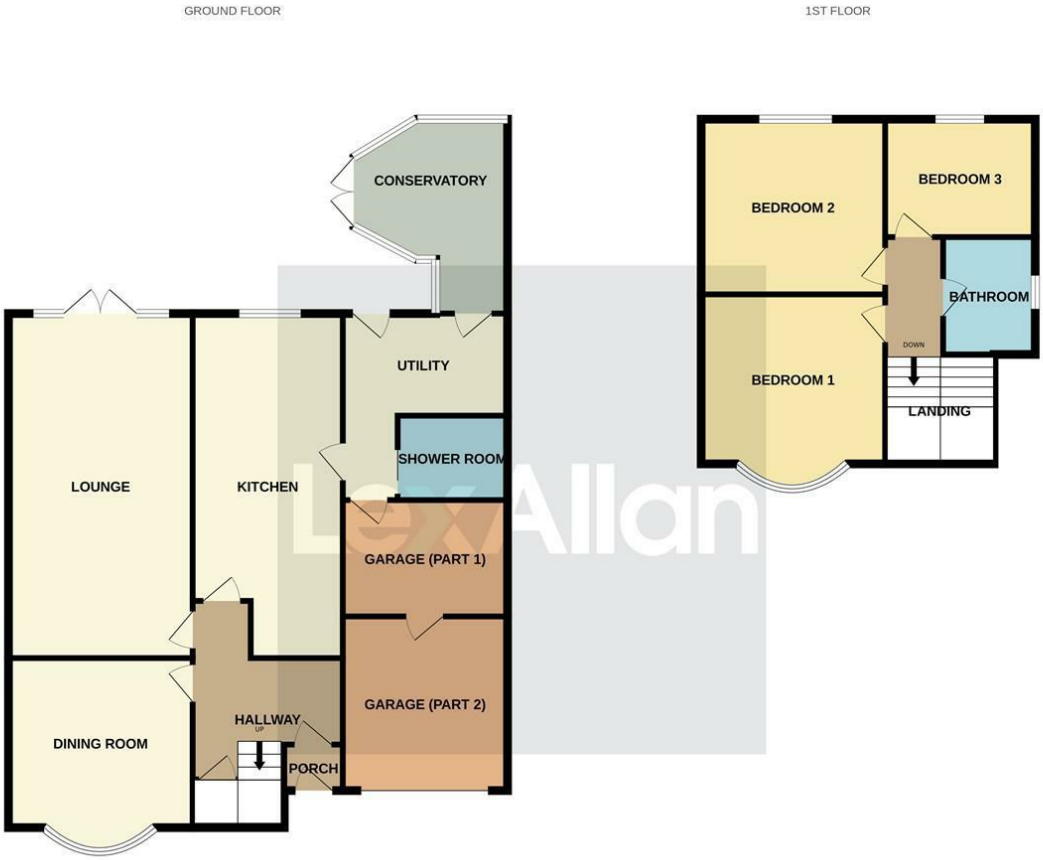
