Porch

Double glazed windows and door, and tiled flooring.

Lounge

Double glazed window to front and central heating radiator.

Dining Room/Bedroom Two

Double glazed window and door to rear garden.

Cupboard, access to loft space and doors off.

Double glazed window to front, central heating radiator and fitted wardrobe.
