Doors and cupboards off, access to loft space and intercom system.

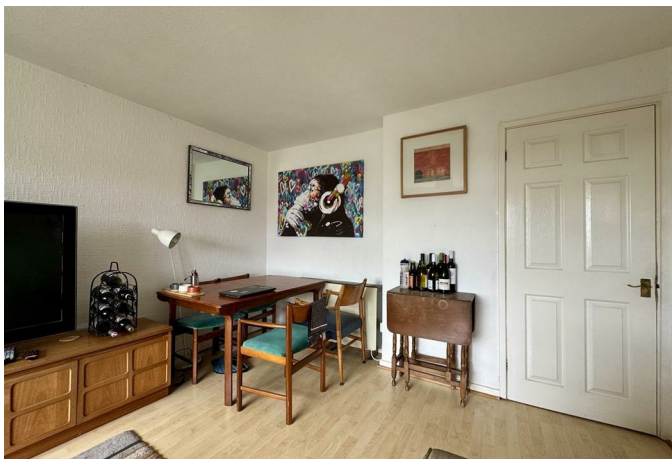

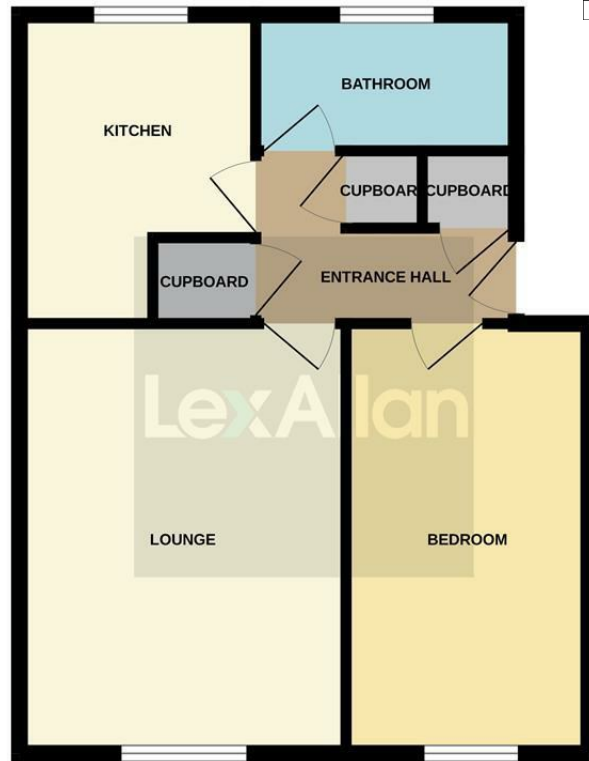
Tenure (Leasehold).
