Doors and cupboards off, access to loft space and intercom system.

#### Lounge

Double glazed window to front with far reaching views and storage heater.

#### Bedroom One

8'6" x 13'9" (2.6 x 4.2)

Double glazed window to front with far reaching views and storage heater.

#### Kitchen

Double glazed window to rear, range of wall and base units with work surface over incorporating sink, space and plumbing for washing machine, tiled splash backs and wall mounted fan heater.

Double glazed window to rear, WC, wash hand basin with mixer tap, bath with mixer tap and electric shower over, heated towel rail, tiled floor and splash backs.

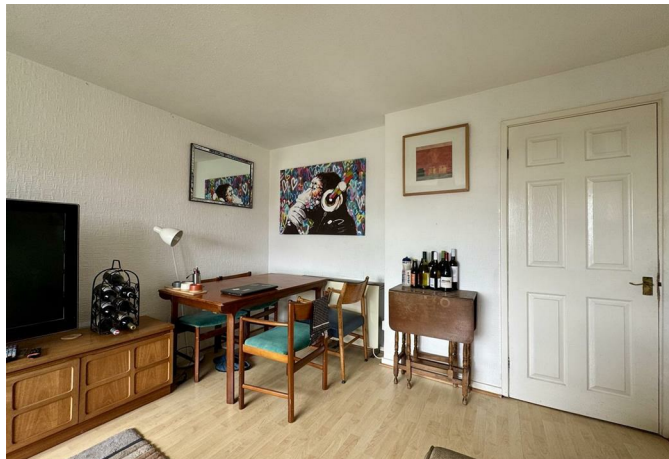

### Tenure (Leasehold).

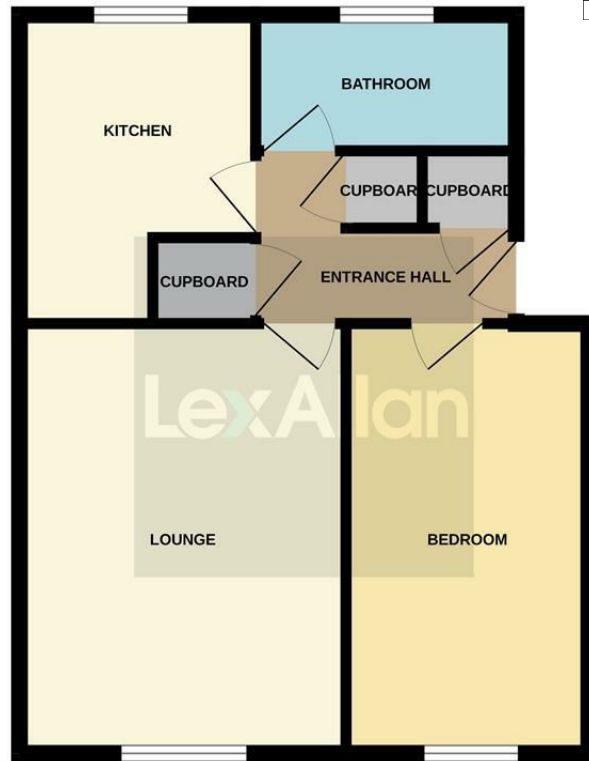
