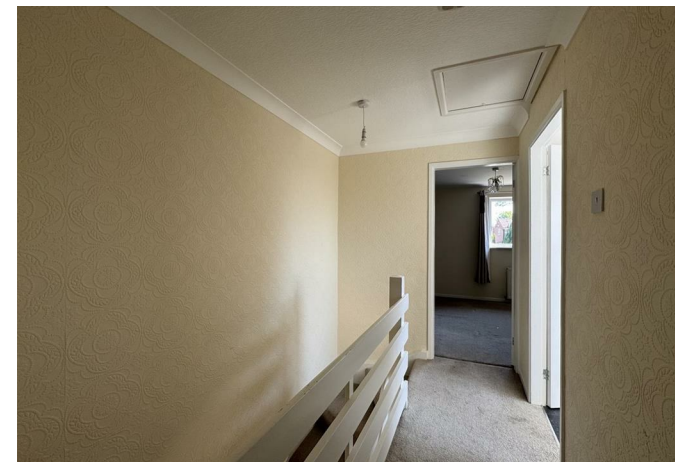
### Referral Fees.

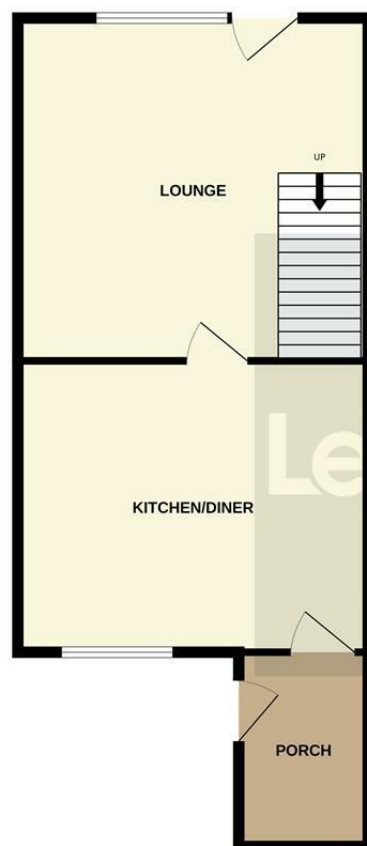

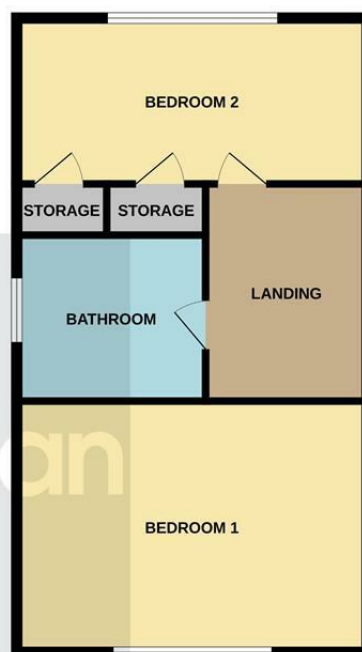
