Approach

Communal parking area with one allocated space to the front of the apartment.

Entrance Hall

Door to front with stairs leading up to apartment.

Lounge

9' 10" min 12' 1" max x 14' 5" (3.0 min 3.7 max x 4.4)

Double glazed windows to front, storage heater and cupboard off.

Kitchen

7' 10" x 6' 6" (2.4 x 2.0)

Double glazed window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob, oven, space and plumbing for washing machine, tiled splash backs and fan heater.

Inner Hall

Cupboard and doors off.

Bedroom

10' 9" x 9' 2" (3.3 x 2.8)

Double glazed window to rear, storage heater, built in wardrobe and access to loft space.

Bathroom

Bath with electric shower over, wash hand basin, WC, heated towel rail, tiled walls, extractor fan and electric fan heater.

Communal garden

Lawn area to rear with flower beds and gives access to private storage shed.

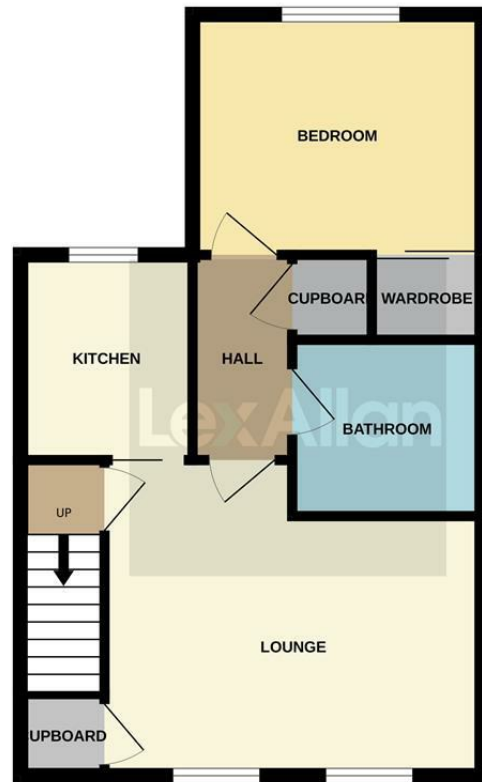
Tenure (Leasehold).
