With NO UPWARD CHAIN this three bedroom semi detached property has the makings for a fantastic family home. Sitting on the corner of Fairfield Road and Highfield Road the property gives spacious accommodation on the large plot which must be viewed to be fully appreciated.

The property itself comprises of driveway giving access to the double garage, porch, hallway, lounge, kitchen and dining room. To the first floor are three bedrooms (the rear with far reaching views) and house bathroom. Finally the large garden to the rear.

#### Approach

Gates give access to block paved drive offering parking for a number of cars, lawn and flower beds to side.

#### Porch

Double glazed windows and door, and tiled floor.

#### Hallway

Door to front, double glazed window to side, central heating radiator, stairs and cupboard off.

#### Lounge

12'5" x 12'9" (3.8 x 3.9)

Double glazed bay window to front, central heating radiator and gas fire.

#### Dining Room

11'5" x 10'5" (3.5 x 3.2)

Double glazed French doors opening to rear garden, central heating radiator, gas fire and built in cupboard.

#### Kitchen

10'5" x 7'2" (3.2 x 2.2)

Double glazed window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, space and plumbing for washing machine, tiled floor and splash backs.

#### Garage

18'8" x 18'0" (5.7 x 5.5)

Double glazed window to rear, roller main door to front, further doors to front and rear.

#### Landing

Double glazed window to side, access to loft space, cupboard and doors off.

Double glazed window to front and central heating radiator.

**Bedroom Two**  
**12'5" x 8'10" (3.8 x 2.7)**

Central heating radiator, double glazed window to rear with far reaching views and built in wardrobe.

**Bedroom Three**  
**7'6" x 9'10" (2.3 x 3.0)**

Double glazed window to front, central heating radiator and cupboard off.

**Bathroom**

Shower, double glazed window to rear, wash hand basin with mixer tap and storage below, WC, tiled floor and splash backs.

**Rear Garden**

Patio area, lawn, flower beds and fencing to enclose.

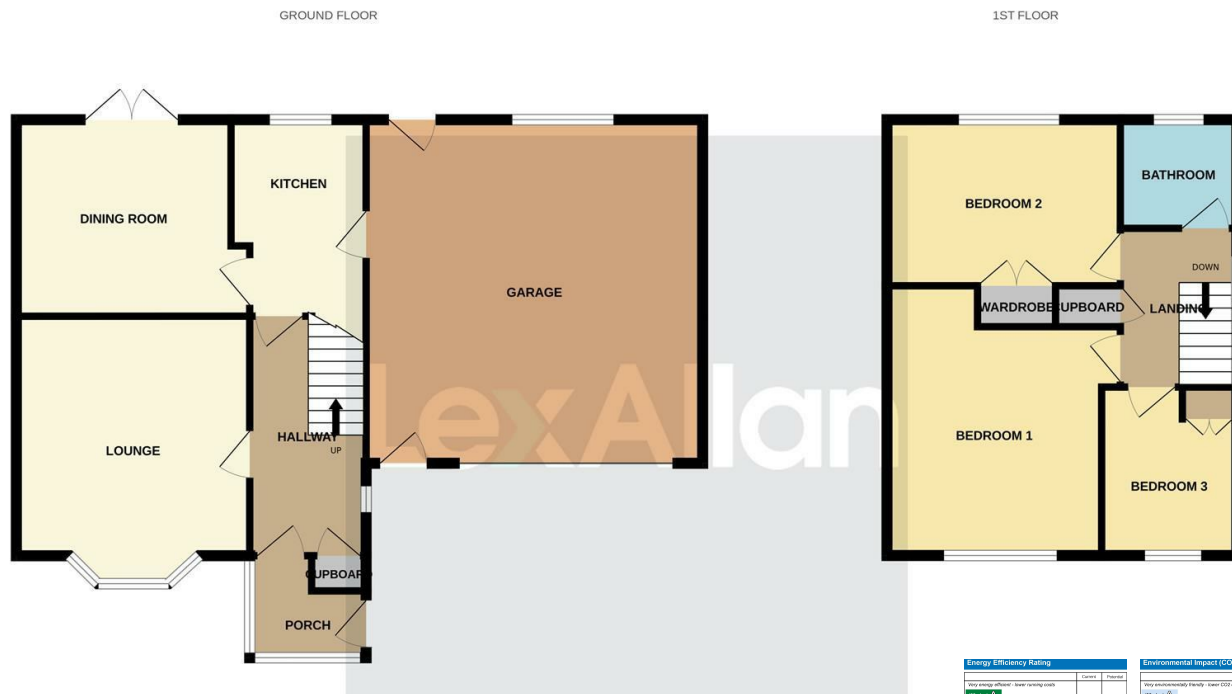
**Tenure (Freehold).**

References to the tenure of a property are based on information supplied by the seller. We are advised that the property is freehold. A buyer is advised to obtain verification from their solicitor.

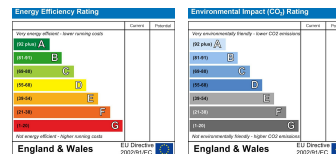
