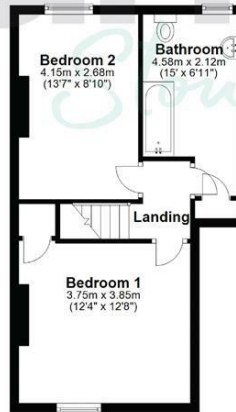




Ground Floor
