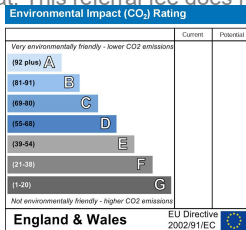
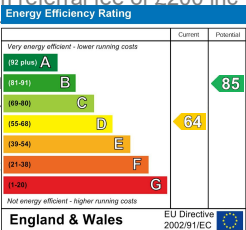
Referral Fees.

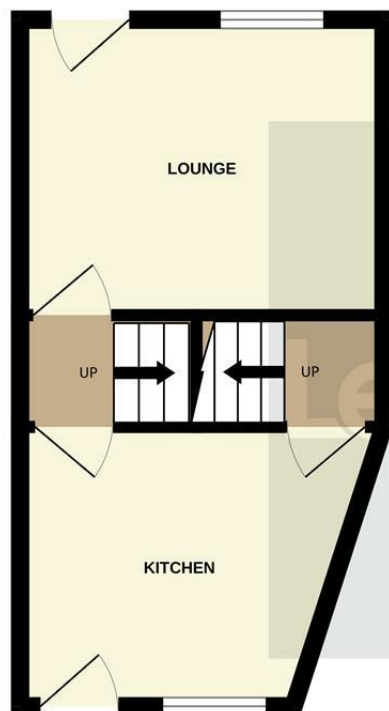

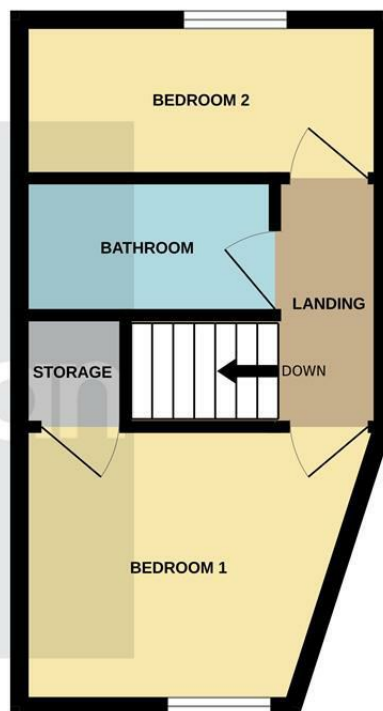

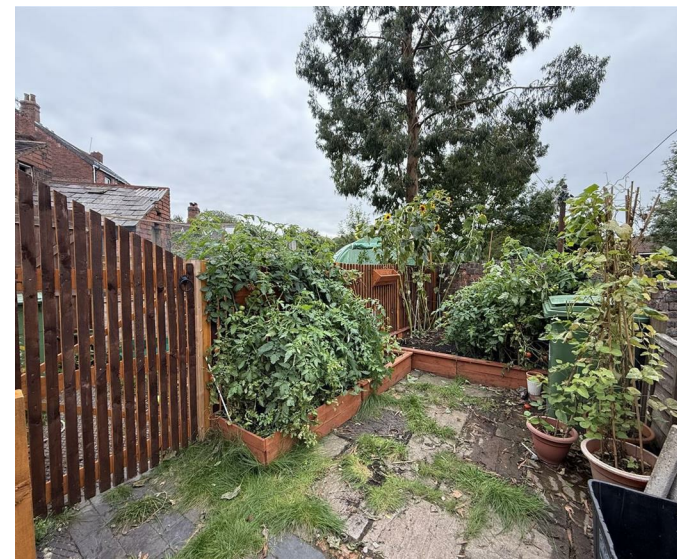
GROUND FLOOR
