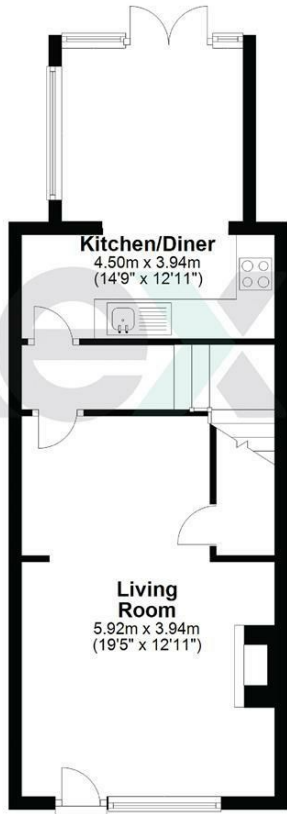
Council Tax Band B





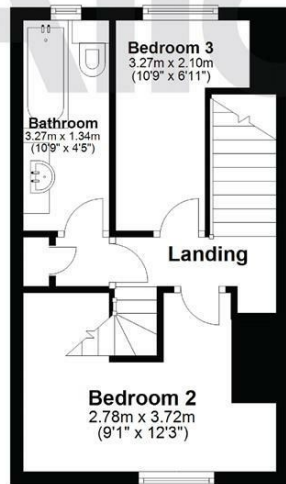
Ground Floor

Second Floor

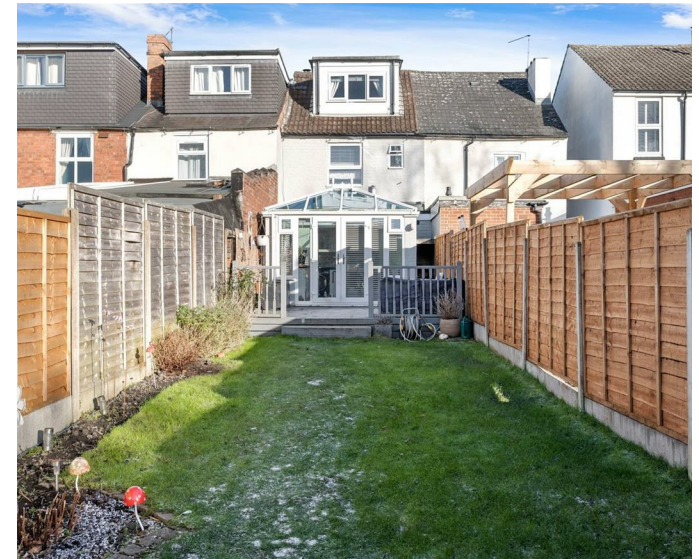
