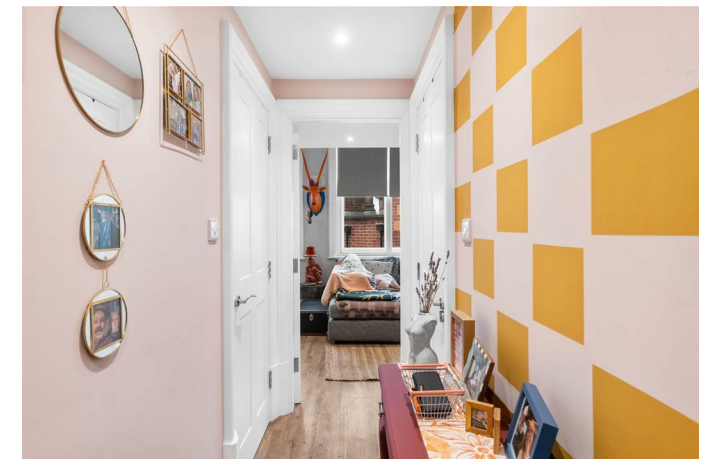

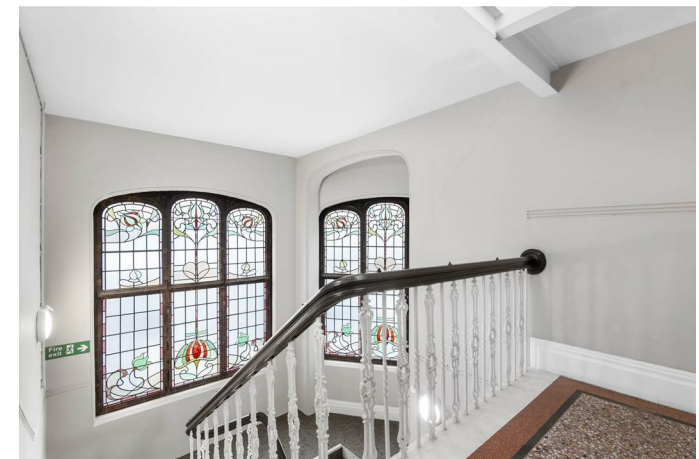
### Money Laundering Regulations.

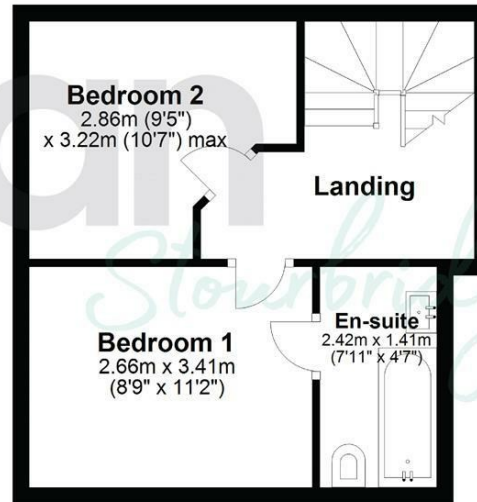
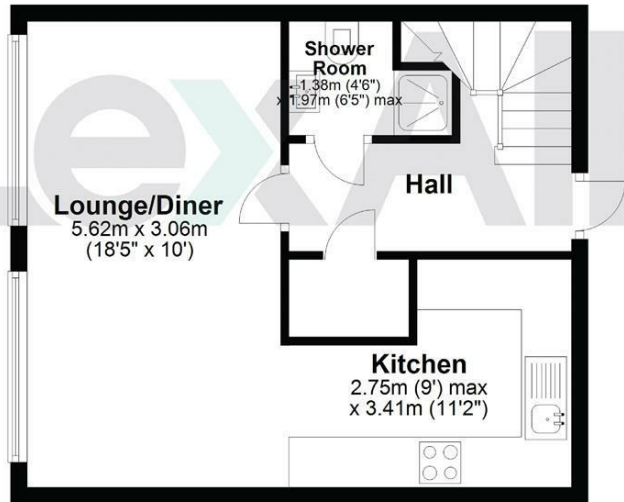
