Slabbed pathway leading to the entrance of the property.

Two allocated parking spaces to front.

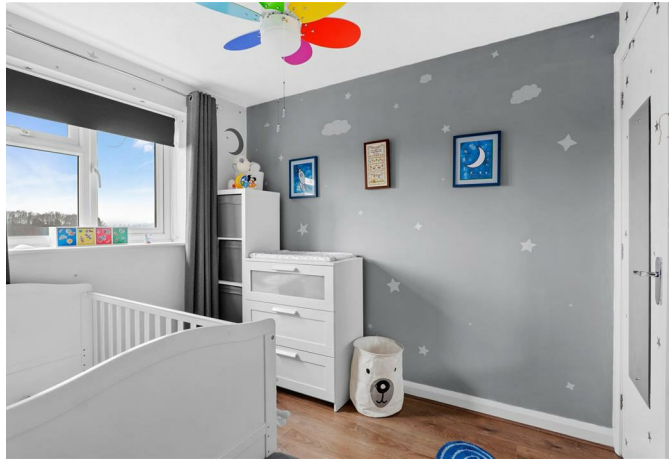
### The Location

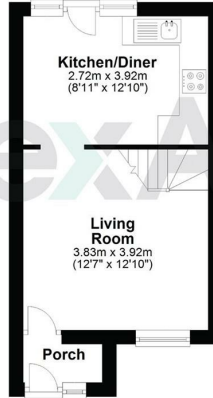

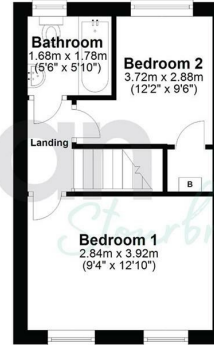

Approx. 26.1 sq. metres (280.6 sq. feet)



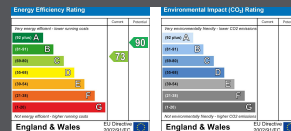
