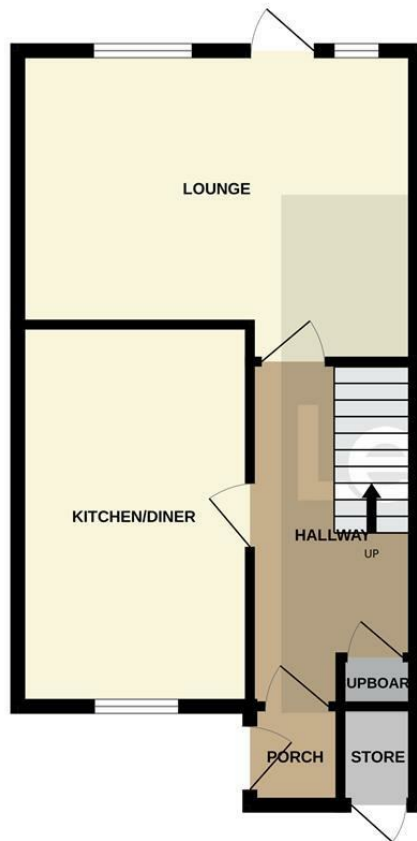
Tenure (Freehold).

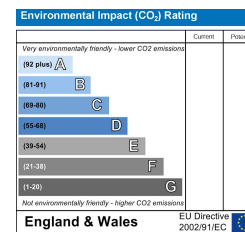
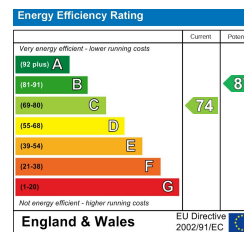
