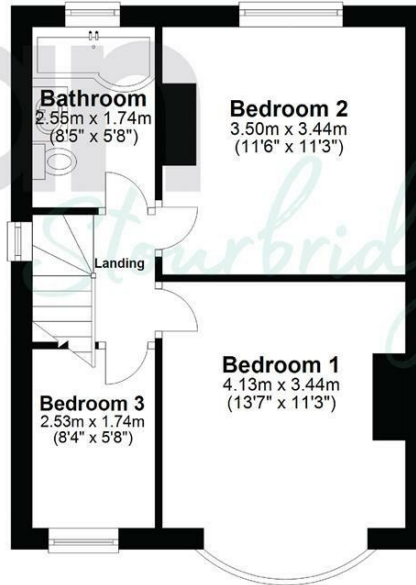
### Ground Floor
