Double glazed window to front, multi fuel burner, central heating radiator and stairs off

Central heating radiator, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob and oven, double glazed window to side, tiled floor and splash backs

#### Utility

Double glazed door to rear, space and plumbing for washing machine with work surface over, and combi boiler

#### Shower room

Shower, low level w,c, double glazed window to rear, wash hand basin with mixer tap and storage below, heated towel rail and tiled splash backs

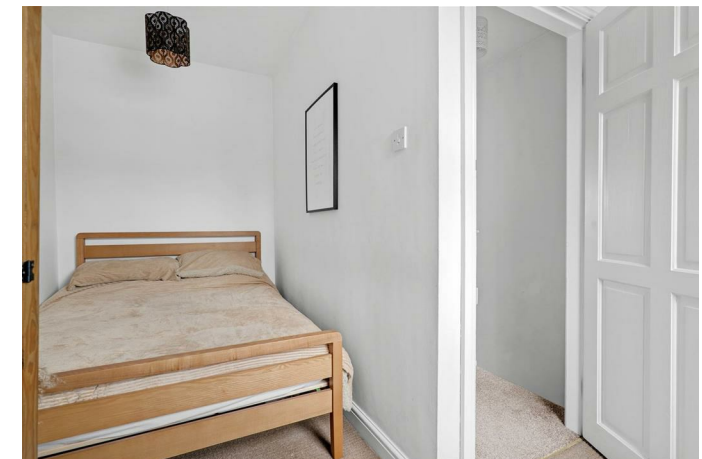
### Referral Fees.

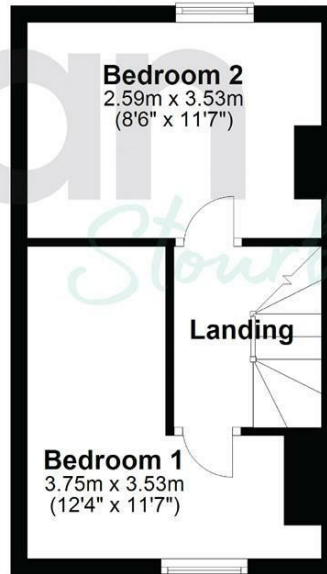
