#### Area

The property is ideally located for the amenities of Mile End Road including the famous Genesis Cinema and the Whitechapel Gallery with Bethnal Green, Spitalfields and Brick Lane all within easy reach.

Nearby transport links include Whitechapel Overground and Underground station (District and H&C lines), Bethnal Green Stations (both overground and underground) as well as the A11 and A13. A number of well-connected bus routes also run along Mile End Road and Whitechapel Road providing easy access to the City, Central London and Stratford if heading east.

The green open spaces of Weaver's Fields, Bethnal Green Gardens, Stepney Green Park and Mile End Park are all within walking distance.


