LOCATION

Corbridge is an affluent village situated in the Tyne Valley, approximately 15 miles west of Newcastle upon Tyne and 5 miles east of Hexham. The village lies immediately south of the A69 Trunk road which connects Newcastle in the east to Carlisle in the west. There is also a main line railway station which lies adjacent to the subject property.

The village is popular with both residents and tourists and enjoys a range of facilities including a selection of shops, bars, restaurants and other facilities.

The subject property is located adjacent to the railway station, on the south side of the river within a mixed use office, nursery and industrial development.





DESCRIPTION

The property comprises a semi-detached industrial unit of steel portal frame construction with brick elevations and pitched roof. It benefits from UPVC double glazed windows. The building has been divided into two units.

Unit 1 comprises an industrial unit with showroom/office accommodation spread over ground floor and mezzanine. The building is heated by a gas fired central heating system to radiators. The unit benefits from a loading door approximately 3 metres wide x 3.4 metres high with an eaves height of 5.8 metres and ridge height of 6.8 metres.

The property has previously been occupied as a showroom and workshop. Tenants are responsible for obtaining any necessary planning consent for their proposed use.


ENERGY PERFORMANCE CERTIFICATE
