A rare opportunity to acquire a detached static park home, occupying a corner plot situated at the entrance to Oversley Mill Park, Alcester.

Externally, the property benefits from two private block-paved areas, providing off-road parking space, and a gated front and back garden entrance. The outdoor space is split level and laid to patio slabs, perfect for garden furniture, then laid to lawn with a mature planted border, giving a sheltered garden area.

The property is accessed via two sets of steps and opens onto the hall. The rest of the accommodation then comprises: Lounge with dual aspect windows and patio door, kitchen with space for freestanding appliances, double bedroom one with a rear window and space for wardrobes, bedroom two/dressing room, and the bathroom, providing a bath with overhead shower, sink and WC.




