The property is approached via a sizeable block-paved driveway, accommodating several vehicles. Mature shrubs and a low wall screen the house from the road The garage is accessed through an automated up-and-over door.

The property opens into an enclosed porch, opening then into a welcoming hallway connecting the ground floor rooms. The kitchen is a practical and well-appointed space, offering a gas hob with extractor hood, electric oven, integrated dishwasher, and an understairs pantry —maximising use of space. Adjacent to the kitchen is the dining room, a large and bright space with ample room for a dining table and additional furniture. Through a sliding door is the spacious lounge with a sizeable bay window overlooking the front garden. Bedroom Four, currently used as a second reception room, also looks out to the front. Ascending to the first floor, the central landing has doors radiating to each room.
