



How this affects your energy bills

An average household would need to spend £1,091 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

Step 1: Floor insulation (suspended floor)

Potential rating after completing steps 1 and 2	71 C

Step 3: Replace boiler with new condensing boiler

Typical installation cost	£2,200 - £3,000
Typical yearly saving	£109
Potential rating after completing steps 1 to 3	74 C
